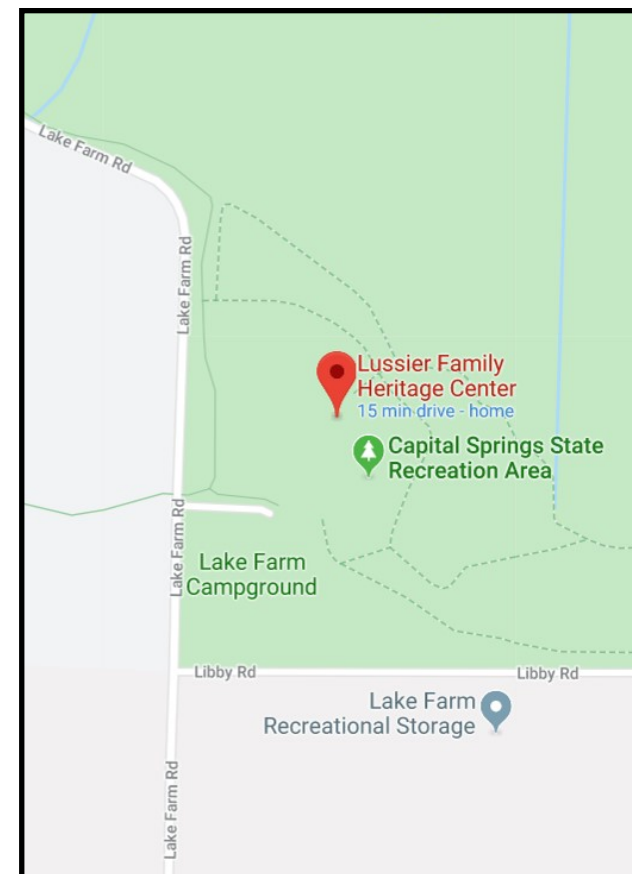

Dane County UW-Extension 2020 Winter Seminar Series

Week 1: JANUARY 10

8:45-10:15 AM - New and Emerging Plant Diseases: Brian Hudelson of the UW-Madison Plant Disease Diagnostic Clinic will cover new & emerging diseases that have appeared in the past few years and some we should be watching for in 2020.

10:30 AM-12:00 Developing, Selecting, and Introducing New Woody Plants in Wisconsin: Mike Yanny from JN Plant Selections will present on his woody plant breeding program including plants such as Firespire® Carpinus, Firebird® crabapple, and Pink-a-licious™ spirea.

Week 2: JANUARY 17

8:45-10:15 AM The Big Chill: Cold temperature effects on plants and avoiding damage: Dr. Laura Jull of UW-Madison will focus on how plants acclimate and tolerate severe winter temperatures. Discover what happens from the cellular level to the tops of buds during winter.

10:30 AM-12:00 PM: Perennials: New Trends, Plants and Varieties: Nancy Nedveck of The Flower Factory will cover all of this plus plants for adapting to the changing climate.

Week 3: JANUARY 24

8:45-10:15 AM: Insect Damage by Mouthpart Type: PJ Liesch of the UW-Madison Insect Diagnostic Lab will speak on various landscape pests in terms of categories of insect damage: sucking, chewing and boring-type damage.

10:30 AM-12:00 PM: Wildlife Damage Management by Species: David Drake will discuss different species of wildlife that cause plant damage, how to identify the culprit and techniques for management.

Week 4: JANUARY 31

8:45-10:15 AM Woody Landscape Plants for Shade: Dave Wanninger, Horticulturist in Charge at the Boerner Botanical Gardens will review a number of species and cultivars of woody plants that do well in light to heavily shaded situations.

10:30 AM -12:00 PM Abiotic Turf Issues and Glyphosate Alternatives: Dr. Paul Koch of the Plant Pathology department at UW-Madison will cover abiotic issues in lawns and give some recommendations for alternatives to RoundUp® (glyphosate).
